## [Purpose and legal basis for personal data processing]

4. Your personal data will be processed:
a. for the purpose necessary for the Controller's ensuring high standards of quality and safety of medicinal products and, in particular, monitoring the safety of medicinal products, including the keeping of records of individual adverse reactions to medicinal products and the reporting of individual adverse reactions to medicinal products to the competent authorities - on the basis of:

9. Your personal data may be made available to entities and bodies authorized to process such data under the law, in particular to the President of the Office of Medicinal Products, Medical Devices and Biocidal Products, the European Medicines Agency and other competent authorities of the Member States of the European Union, in which the Controller has obtained a marketing authorisation for a medicinal product.
10. The Controller does not intend to transfer your personal data outside the European Economic Area or to an international organisation.

## [Personal data storage period]

11. Your personal data shall be processed for the period necessary to achieve the purposes for which the data are processed or until an objection is raised (if the processing is based on the legitimate interest of the Controller) or until the withdrawal of consent (if the processing is based on the given consent) - depending on which of the events occurs earlier.
12. ## [Rights]

13. You have the right to:

c. to the extent that the processing of your personal data is based on consent, the right to withdraw consent to the processing of your personal data at any time.
